



## SEBRING AIRPORT UPDATES

## Haywood Taylor

Final paving will be completed the week of January 9th. Substantial completion is anticipated to occur the week of January 23rd, with final completion February 23rd.

## **Building 22 Re-roofing**

Window installation is scheduled for the week of January 16th. Substantial completion is anticipated to occur in February, with final completion in March.

## Taxiway A4 Realignment

EO Koch has submitted all of their required shop drawings, which have been reviewed and approved. All materials have been ordered and field work is scheduled to begin on Monday, January 23rd. Initial work efforts will focus on surveying stakeout and the installation of the stormwater drainage pipe and structures. This will be followed by grading, subgrade compaction, and installation of base course. Asphalt paving and the installation of taxiway edge lighting are scheduled to be completed in May, with final completion and acceptance in June. This schedule includes a pause in construction for the 12Hours of Sebring race week, which will prevent any operational impacts to the Airport during that busy week.



## **Highmast Apron Lighting**

SAA has applied to the FDOT for a S.A.F.E. grant to design and construct area lighting for the Terminal Apron. The Terminal Apron has limited lighting and the area is extremely dark at night. The addition of area lighting would improve the security and safety on the apron. This project would include six (6) highmast light poles (50' tall) spaced around the Terminal Apron. Anticipated program costs are approximately \$410,000. We are waiting for confirmation from the FDOT on whether there is money in the program to issue a grant in early 2023.

Proclaimed Wayne, "We are on the cusp of the biggest 12 Hours event ever."

The WEC, which has announced plans that indicate this may be the last SuperSebring event, will have seven different hypercar manufacturers, 13 different cars competing for overall victory in the 1000 Miles of Sebring.

Sports car fans are responding with almost certain double-digit percentage increases in advance ticket sales, based on current trends. IMSA also is introducing new hypercars from four different manufacturers that will compete for overall titles in the Mobil 1 Twelve Hours of Sebring.

The development of these new cars has driven record track rental numbers.

IMSA will stage a two-day sanctioned test at Sebring in mid-February, its first since 2016, bringing every competitor in the IMSA WeatherTech Championship and IMSA Michelin Pilot Challenge Series to Sebring Feb. 15-16.

Additionally, Sebring International Raceway is experimenting with several new ticketed events, including SCCA's biggest events, which are arguably some of the most entertaining races on the calendar.



## IAC 23 AEROBATIC CONTEST

The International Aerobatic Club, Chapter 23, held their contest at Sebring Regional Airport last November. This was the 84th consecutive contest hosted in Sebring.

This Chapter typically organizes two contests each year, one in April and the other in November. The number of competitors range from 20 to as many as 100.

Nationally, the IAC conducts contests in nearly every state with championships held in Salinas, KS every October. Said Ken Kopp, IAC Ch 23 Vice President, "We place great emphasis on safety and efficiency conducting thorough pilot and staff briefings each morning prior to commencement of the competition. The pilots are well trained and their planes thoroughly inspected prior to the event by a knowledgeable, qualified pilot. Sebring Airport management and staff have supported our activities throughout the years with professionalism, courtesy and friendliness. We could not do this without them!"

## **About this Event**

Explains Ken, "IAC chapter contest like ours are crucial to furthering the sport providing local aerobatic pilots the opportunity to hone their skills and be critiqued by judges with decades of experience. We also support University Aviation flying programs by hosting student competitors and their coaches. This last event we had 22 competitors from Florida, Georgia and Alabama and completed 66 competition events in two days. Our contests positively impact airport operations through fuel sales and patronage at the airport cafe. We also support local hotels, such as the Sebring Seven in which we purchased 70 room nights over a four-day period, and held our awards banquet with total revenue to the hotel exceeding \$14,000. We contract with local shirt and trophy suppliers as well. A typical contest cost the chapter between \$4-5K to host. We earn revenue through competitor registration fees and sponsor donations. Our biggest hurdle is finding adequate hangar space for our highly specialized aerobatic airplanes which range in value from \$80K to well over \$500K.






